### **Ontario Trillium Foundation Grant Purchases New Van for Community Care Northumberland's Specialized Transportation Program**

Community Care Northumberland (CCN) is excited to announce the receipt of an Ontario Trillium Foundation grant which has allowed them to purchase a new accessible van that will service the residents of Northumberland County.

#### **Official Launch Ceremony of New Accessible Van**

**Date:** Friday, October 21st, 2016

**Location:** Columbus Community Centre, 232 Spencer Street East, Cobourg, Ontario

**Time:** 11:30 am – 12:00 noon

The need for specialized transportation (accessible and rural) is growing in Northumberland County. CCN successfully applied for **\$90,000** through Ontario Trillium Foundation's capital investment stream which allowed them to purchase a Ram Promaster 2500 so that it can meet this need by increasing its current passenger capacity.

This Promaster vehicle has been retrofitted with an auto-floor package, allowing CCN to change the seating configuration to meet the following two seating need options:

- To carry 7 walk-on passengers and 1 wheelchair = total 8 passengers at one time, or
- To carry 3 walk-on passengers and 2 wheelchairs = total 5 passengers at one time

This auto-floor package allows for flexibility in CCN's central scheduling office to have multi-purpose seating options and increase the capacity of CCN to deliver its specialized transportation. Seating can change depending on the pre-booked daily needs of its clients. This new vehicle will be added to the CCN's current fleet of specialized transportation vehicles.

The Ontario Trillium Foundation (OTF) is an agency of the Government of Ontario, and one of Canada's largest granting foundations. With a budget of over \$136 million, OTF awards grants to some 1,000 projects every year to build healthy and vibrant Ontario communities. That means over the next decade, OTF will invest more than \$1 billion in Ontario's public benefit sector.

"This vehicle will be a great asset to our community as CCN expands transportation options across the County. Without the support of the Ontario Trillium Foundation, along with local community groups and Northumberland Municipalities we would not be able to address some difficult transportation challenges for residents in Northumberland County," said Trish Baird - Executive Director. "Community Care Northumberland values collaboration to meet client needs, this is an excellent example of that in action."

The goal of Community Care Northumberland's Specialized Transportation program is to provide an affordable and sustainable service to the residents of Northumberland County who require rural and / or accessible transport to attend medical appointments, community/public services, employment, shopping, area events, and social outings. Community Care Northumberland also continues to operate a Volunteer Driving program for seniors and adults with disabilities. Volunteer drivers use their own personal vehicles and are matched with clients who pay a fee directly to the driver to help reimburse them for their gas.
